KCC Cllr Rayner updated Members on KCC's ongoing financial difficulties, and savings that would have to be made. Better news on School Buses which had performed better in the past year than the previous seven. A parents WhatsApp group was helping. Cllr Rayner had raised the issue of Road Closure chaos at Wrotham Heath at the appropriate KCC Committee in the strongest possible terms, but unfortunately since the inception of the road permit scheme, Utility companies used "Emergency Powers" for even routine repairs, and these closures were happening without any oversight of their impact on the Road Network in general. Cllr Rayner also reported on the latest JTB meeting, which had reintroduced the concept of relevant KCC Officers being present and reporting, and attracting Parishes and Borough Members to what is an important cross-authority liaison group.
